WHEREAS, an updated and correct Exhibit E is attached hereby to this Correction Amendment which accurately reflects as of this date, said correct assignments.



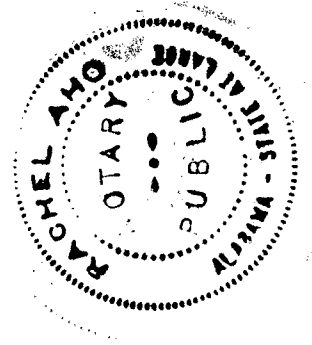
