Phase I improvements have been constructed as described in and referred to in Exhibit "A", attached hereto and made a part hereof, which said Exhibit includes a set of floor plans of each unit in the buildings showing the layout, location, the designated numbers of each unit and bearing the verified statement of a registered engineer that such drawings are in sufficient detail to identify the common elements and the private elements comprising the units and improvements as built.
